

RESOLUTION

#10
AUTHORIZING WALTER O. JOHNSON, JR.,
TO CONSTRUCT A WATER LINE ON THE
YOUNGSTOWN-CANFIELD ROAD (S.H. #62)
IN CORNERSBURG SEWER DISTRICT NO. 14,
CANFIELD TOWNSHIP, MAHONING COUNTY,
OHIO, UNDER AUTHORITY OF SECTION 307.73
OF THE REVISED CODE OF OHIO.

WHEREAS, application for the construction of the water line on
the Youngstown-Canfield Road (S.H. # 62), under Section 307.73, has been
filed with the Mahoning County Commissioners on April 13, 1959 and

WHEREAS, a list of names of lot owners not participating in the
original cost is included with the application and, and,

WHEREAS, a prorated share of the cost of the improvement shall
be collected and returned to WALTER O. JOHNSON, JR., in the event any
non-participant applies for a water tap. The prorated share shall be based
on the foot frontage and shall not exceed the amount chargeable if such
non-participant had participated in the original improvement.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS that WALTER O. JOHNSON, JR., be authorized to proceed
with the installation of a water line on Youngstown-Canfield Road to serve
Lot 11 of Sharp Plat 28-114 measuring 49.64 feet in frontage lot belonging to
Robert M. McCracken, lot part of Great Lot 11, 4th Division measuring
104.25 feet on Route 62; lot belonging to Mazzacco measuring 78.8 feet, of
which lot only 65' of said lot to be covered by said water line lot belonging
to Price measuring total of 352.62 feet. and lot belonging to Sneider measur-
ing 75'.

BE IT FURTHER RESOLVED, that said Board shall collect and
return to WALTER O. JOHNSON, JR., a prorated share of the costs of
the improvement to be determined when WALTER O. JOHNSON, JR., sub-
mits the final cost of the completed improvement to the County Sanitary
Engineer, 940 Bears Den Road, Youngstown, Ohio from which the rate
per foot shall be determined.

It was moved by CARNEY, seconded by Mr. GILRONAN
that the foregoing resolution be approved and passed this 22 day
of APRIL, 1959.
