AUTHORIZING HENRY HASSAY OF ~~628~~ CLINGAN ROAD,
POLAND, OHIO, TO PROCEED UNDER SECTION 307.73
REVISED CODE OF THE STATE OF OHIO, WITH THE
CONSTRUCTION OF 600 FEET OF 8-INCH SANITARY
SEWER FROM AN EXISTING MANHOLE IN FRONT OF A
3.028 ACRE PARCEL OF LAND OWNED BY HENRY HASSAY,
NORTHERLY 600 FEET THEREFROM IN CLINGAN ROAD
IN POLAND TOWNSHIP, MAHONING COUNTY, OHIO.

WHEREAS, a letter of application to proceed under Section 307.73 R.C.
of Ohio with the installation of a sanitary sewer at the above described
location has been filed with this Board, and

WHEREAS, any non-participants along the line of the installation shall
be required to pay a pro-rated share of the construction costs, based on
the front footage, and

WHEREAS, certified copies of the completed work shall be filed at the
office of the Mahoning County Sanitary Engineer, 761 Industrial Road, Young-
stown, Ohio, 44509, so that a tapping charge to non-participants may be
determined, and

WHEREAS, in accordance with amended Section 307.73 R.C. effective
August 23, 1972, a one dollar Auditors filing fee received of Henry Hassay
accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners
of Mahoning County, State of Ohio, that Henry Hassay be and he is hereby
authorized to proceed under Section 307.73 R.C. with the construction of
600 feet of 8-inch sanitary sewer from an existing manhole on Clingan Road,
in front of a 3.028 acre parcel of land owned by said Henry Hassay, north-
erly 600 feet therefrom in Poland Township, Mahoning County, Ohio, in
accordance with the regulations governing sewer construction in Mahoning
County.

BE IT FURTHER RESOLVED that any monies collected from non-participants
shall be forwarded to the applicant.
