

RESOLUTION

AUTHORIZING GLENWOOD PARK ESTATES, INC. OF
3390 FLO-LOR DRIVE, YOUNGSTOWN, OHIO, 44511
TO PROCEED UNDER SECTION 307.73 R.C. OF OHIO,
WITH THE CONSTRUCTION OF AN 18" SANITARY SEWER
BEGINNING AT GLENWOOD AVENUE AND SHARROTT ROAD,
THENCE WESTERLY IN WESTERN RESERVE ROAD AN APP-
ROXIMATE DISTANCE OF 2,100 FEET TO HITCHCOCK
ROAD, THENCE NORTHERLY IN HITCHCOCK ROAD AN
APPROXIMATE DISTANCE OF 575 FEET TO AN EXISTING
SANITARY SEWER LINE IN BOARDMAN TOWNSHIP, MAHONING
COUNTY, OHIO.

WHEREAS, a letter of application to proceed under Section
307.73 R.C. of Ohio with the installation of a sanitary sewer at
the above described locations has been filed with this Board, and

WHEREAS, any non-participants along the line of the install-
ation shall be required to pay a pro-rata share of the construct-
ion costs, based on the front footage, and

WHEREAS, certified copies of the completed work shall be
filed at the office of the County Sanitary Engineer, 761 Indust-
rial Road, Youngstown, Ohio, so that a tapping charge to non-
participants may be determined, and

WHEREAS, in accordance with amended Section 307.73 R. C.
of Ohio, effective August 23, 1972, a one dollar Auditors Filing
Fee received of said Glenwood Park Estates, Inc., accompanies
this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County
Commissioners of Mahoning County, State of Ohio, that Glenwood
Park Estates, Inc., be, and they are hereby authorized to proceed
under Section 307.73 R. C. of Ohio with the construction of an
18-inch sanitary sewer beginning at Glenwood Avenue and Sharrott
Road, thence westerly in Western Reserve Road an approximate
distance of 2,100 feet to Hitchcock Road, thence northerly in
Hitchcock Road an approximate distance of 575 feet to an existing
sanitary sewer line in Boardman Township, Mahoning County, Ohio,
in accordance with the regulations governing sewer line const-
ruction in Mahoning County.

BE IT FURTHER RESOLVED that any monies collected from
non-participants shall be forwarded to the applicant.

It was moved by Mr. Barrett seconded by Mr. Palermo
that the foregoing resolution be approved and passed this 6
day of April, 1978.
