

RESOLUTION

AUTHORIZING VRANCHES AND WALL CONST-  
RUCTION COMPANY OF 545 SAMUEL STREET,  
YOUNGSTOWN, OHIO, 44502, TO PROCEED  
UNDER SECTION 307.73 R. C. OF OHIO,  
WITH THE CONSTRUCTION OF AN 8-INCH  
SANITARY SEWER LINE APPROXIMATELY  
820 FEET IN LOCKWOOD BOULEVARD FROM  
ALISSA COURT SOUTHERLY IN BOARDMAN  
TOWNSHIP, MAHONING COUNTY, OHIO.

WHEREAS, a letter of application to proceed under Section  
307.73 R.C. of Ohio with the installation of a sanitary sewer  
line at the above described location has been filed with this  
Board, and

WHEREAS, any non-participants along the line of the install-  
ation shall be required to pay a pro-rata share of the construct-  
ion costs, based on the front footage, and

WHEREAS, certified copies of the completed work shall be  
filed at the office of the County Sanitary Engineer, 761 Indust-  
rial Road, Youngstown, Ohio, so that a tapping charge to non-  
participants may be determined, and

WHEREAS, in accordance with amended Section 307.73 R. C.  
of Ohio, effective August 23, 1972, a one dollar Auditors Filing  
Fee received of said Vranches and Wall Construction Company  
accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County  
Commissioners of Mahoning County, State of Ohio, that Vranches  
and Wall be, and they are hereby authorized to proceed under  
Section 307.73 R.C. of Ohio, with the construction of an 8-inch  
sanitary sewer line approximately 820 feet in Lockwood Boulevard  
from Alissa Court southerly in Boardman Township, Mahoning County,  
Ohio, in accordance with the regulations governing sewer line  
construction in Mahoning County.

BE IT FURTHER RESOLVED that any monies collected from  
non-participants shall be forwarded to the applicant.
