WITH THE CONSTRUCTION OF AN 12-INCH
WATER LINE APPROXIMATELY 865 FEET IN
LOCKWOOD BOULEVARD FROM ALISSA COURT
SOUTHERLY IN BOARDMAN TOWNSHIP, MAH-
ONING COUNTY, OHIO.

WHEREAS, a letter of application to proceed under Section 307.73 R.C. of Ohio with the installation of a water line at the above described location has been filed with this Board, and

WHEREAS, any non-participants along the line of the installation shall be required to pay a pro-rata share of the construction costs, based on the front footage, and

WHEREAS, certified copies of the completed work shall be filed at the office of the County Sanitary Engineer, 761 Industrial Road, Youngstown, Ohio, so that a tapping charge to non-participants may be determined, and

WHEREAS, in accordance with amended Section 307.73 R. C. of Ohio, effective August 23, 1972, a one dollar Auditors Filing Fee received of said Vranches and Wall Construction Company accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Mahoning County, State of Ohio, that Vranches and Wall be, and they are hereby authorized to proceed under Section 307.73 R.C. of Ohio, with the construction of a 12-inch water line approximately 865 feet in Lockwood Boulevard from Alissa Court southerly in Boardman Township, Mahoning County, Ohio, in accordance with the regulations governing water line construction in Mahoning County.

BE IT FURTHER RESOLVED that any monies collected from non-participants shall be forwarded to the applicant.
