

RESOLUTION

AUTHORIZING MONUS-HANDEL PARTNERSHIP  
8440 MARKET STREET, YOUNGSTOWN, OHIO 44512, TO PROCEED UNDER OHIO  
REVISED CODE SECTION 307.73 WITH THE  
CONSTRUCTION OF AN 8" SANITARY SEWER TO SERVICE THE  
SHOPS AT BOARDMAN PARK, BOARDMAN TOWNSHIP.

WHEREAS, a letter of application to proceed under Ohio Revised Code Section 307.73 with construction of a sanitary sewer to service the Shops at Boardman Park, Boardman Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the sewer line consisting of 8" PVC and a bore in SR 224 at Applewood Blvd., and has recommended the Board approve the request to construct the sanitary sewer line, and

WHEREAS, the cost distribution for the benefitting properties shall be as provided in correspondence received from the Monus-Handel Partnership and attached to this resolution, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been submitted by Monus-Handel Partnership and accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Mahoning County, State of Ohio, that the Monus-Handel Partnership be, and they are hereby authorized to proceed under Ohio Revised Code Section 307.73 with the construction of 8" PVC sanitary sewer and a bore at Applewood Blvd. and SR 224, Boardman Township, and to comply with provisions regulating the construction of sanitary sewers in Mahoning County.

BE IT FURTHER RESOLVED, that any monies collected from benefitting properties shall be forwarded to Monus-Handel Partnership as per attachment.


It was moved by Mr. Carney, and seconded by Mr. Yurcho, that the foregoing Resolution be approved this 8th day of January, 1992.


