

RESOLUTION

AUTHORIZING PERKINS BUILDERS COMPANY, 43 ORCHARD DRIVE,
POLAND, OHIO 44514, TO PROCEED UNDER OHIO REVISED CODE SECTION
307.73 WITH THE CONSTRUCTION OF AN 8" SANITARY SEWER IN SHIELDS ROAD,
EAST FROM TROTTER DRIVE, BOARDMAN TOWNSHIP

WHEREAS, a letter of application to proceed under Ohio Revised Code
Section 307.73 with construction of a sanitary sewer in Shields Road, Boardman
Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the
sewer line and has recommended the Board approve the request to construct the
sanitary sewer line, and

WHEREAS, any non-participants, specifically lots 6,7,8,9 and 10, tax
map plate 82, Boardman Township, along the line of the installation of the
sanitary sewer benefitting from the construction shall be required to pay a pro-
rata share of the project costs calculated on the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73
dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been
submitted by Perkins Builders Company and accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED, by the board of County Commissioners
of Mahoning County, State of Ohio, that Perkins Builders Company, 43 Orchard
Drive, Poland, Ohio 44514 be, and they are hereby authorized to proceed under
Ohio Revised Code Section 307.73 with the construction of an 8" sanitary sewer
easterly in Shields Road, north side of the roadway, from Trotter Drive, Boardman
Township in accordance with provisions regulating the construction of sanitary
sewers in Mahoning County.

BE IT FURTHER RESOLVED, that any monies collected from non-partici-
pants shall be forwarded to Perkins Builders Company.

It was moved by Mr. Carney, and seconded by Mr. Yurcho, that the
foregoing Resolution be approved this 5th day of September, 1991.


