AUTHORIZING JOE KOCH CONSTRUCTION COMPANY,  
352 WYNDCLIFT DRIVE, AUSTINTOWN, OHIO 44515  
TO PROCEED UNDER OHIO REVISED CODE  
SECTION 307.73 WITH THE CONSTRUCTION OF  
AN 8" WATER LINE IN WILCOX ROAD,  
SOUTH FROM CALLAWAY CIRCLE, AUSTINTOWN, TOWNSHIP

WHEREAS, a letter of application to proceed under Ohio Revised Code Section 307.73 with construction of a water line in Wilcox Road, Austintown Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the water line and has recommended the Board approve the request to construct the water line, and

WHEREAS, any non-participants along the line of the installation of the water line benefitting from the construction shall be required to pay a pro-rate share of the project costs calculated on the the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been submitted by the Joe Koch Construction, Inc. and accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Mahoning County, State of Ohio, that Joe Koch Construction, Inc., 352 Wyndclift Drive, Austintown, Ohio 44515 be, and they are hereby authorized to proceed under Ohio Revised Code Section 307.73 with the construction of an 8" water line southerly in Wilcox Road from Callaway Circle, Austintown Township in accordance with provisions regulating the construction of water lines in Mahoning County.


BE IT FURTHER RESOLVED, that any monies collected from non-participants shall be forwarded to Joe Koch Construction, Inc.


