

RESOLUTION

AUTHORIZING GEORGE T. JORDAN, 6262 MAHONING AVENUE, YOUNGSTOWN, OHIO 44515,
TO PROCEED UNDER OHIO REVISED CODE SECTION 307.732 WITH THE
CONSTRUCTION OF AN 8" SANITARY SEWER IN VICTORIA ROAD, AUSTINTOWN, OHIO

WHEREAS, in a letter of application to proceed under Ohio Revised Code Section 307.73 with construction of a sanitary sewer in Victoria Road, Austintown Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the sewer line and has recommended the Board approve the request to construct the sanitary sewer line, and

WHEREAS, any non-participants, specifically lot(s) on the east side of Victoria Road along the line of the installation of the sanitary sewer benefitting from the construction shall be required to pay a pro-rata share of the project costs calculated on the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been submitted by George T. Jordan and accompanies this resolution.


NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Mahoning County, State of Ohio, that George T. Jordan, 6262 Mahoning Avenue, Youngstown, Ohio 44515, be, and he is hereby authorized to proceed under Ohio Revised Code Section 307.73 with the construction of approximately 805 feet of 8" sanitary sewer in Victoria Road, approximately 1009' north of Mahoning Avenue then traveling south on the easterly side of the roadway, Austintown Township in accordance with provisions regulating the construction of sanitary sewers in Mahoning County.

BE IT FURTHER RESOLVED, that any monies collected from non-participants shall be forwarded to George T. Jordan.


It was moved by Mr. Palermo, and seconded by Mr. Carney, that the foregoing Resolution be approved this 12th day of November, 1992.


