AUTHORIZING MILL CREEK ENTERPRISES, INC.
P.O. BOX 3318, YOUNGSTOWN, OHIO 44513 TO PROCEED UNDER OHIO
REVISED CODE SECTION 307.73 WITH THE CONSTRUCTION OF 12"
WATER LINE IN NEW ROAD, FROM SR 46 (NILES-CANFIELD ROAD) TO
TURNER ROAD, AUSTINTOWN TOWNSHIP.

WHEREAS, a letter of application to proceed under Ohio Revised Code
Section 307.73 with construction of water line in Austintown Township has been
received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed routes of
the water line and has recommended the Board approve the request to construct the
water line, and

WHEREAS, any non-participants, specifically lot(s) on New Road along
the route of the water line benefitting from the construction shall be required
to pay a pro-rata share of the project costs, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73
dated March 15, 1969, a one dollar (\$1.00) Auditor's Filing Fee has been
submitted by Mill Creek Enterprises, Inc. and accompanies this resolution.


NOW, THEREFORE, BE IT RESOLVED, by the Board of Mahoning County

regulating the construction of water lines in Mahoning County.

participants shall be forwarded to Mill Creek Enterprises, Inc.


