AUTHORIZING ANTOUN DIBO,  
6485 DIANA DRIVE, POLAND OHIO, 44514  
TO PROCEED UNDER OHIO REVISED CODE SECTION 307.73  
WITH THE CONSTRUCTION OF AN 250' OF 8" SANITARY SEWER  
IN WALKER MILL ROAD, POLAND TOWNSHIP

WHEREAS, a letter of application to proceed under the Ohio Revised Code Section 307.73 with the construction of 250' of 8" sanitary sewer in Walker Mill Road and Clovermead Drive, Poland Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the water line and has recommended the Board approve the request to construct the sanitary sewer line, and

WHEREAS, any non-participants, specifically lot(s) on the north side of Walker Mill Road, lots 1 and 2, J. William Plat No. 1 and lot 3, benefitting from the construction shall be required to pay a pro-rata share of the project costs calculated on the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been submitted by Antoun Dibo and accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Mahoning County, State of Ohio, that Antoun Dibo, 6485 Diana Drive, Poland, Ohio 44514, be, and is hereby authorized to proceed under Ohio Revised Code Section 307.73 with the construction of approximately 250 feet of 8" sanitary sewer in Walker Mill Road, beginning at Clovermead Drive then traveling east on the north side of Walker Mill Road, Poland Township, in accordance with provisions regulating the construction of sanitary sewers in Mahoning County.


BE IT FURTHER RESOLVED, that any monies collected from non-participants shall be forwarded to Antoun Dibo.

It was moved by Mr. Lordi, and seconded by Mr. Carney, that the foregoing Resolution be approved this 29th day of April, 1993.


