

RESOLUTION

**AUTHORIZING MR. FREDERICK ROMEO, 4636 NORTHQUEST BOULEVARD, AUSTINTOWN, OHIO 44515
TO CONSTRUCT A SANITARY SEWER IN AUSTINTOWN TOWNSHIP,
OHIO IN ACCORDANCE WITH OHIO REVISED CODE SECTION 307.73**

WHEREAS, the Board of Mahoning County Commissioners received a recommendation from the Mahoning County Sanitary Engineer to approve the construction of a sanitary sewer to be located in North Turner Road and being approximately 182 L.F. in length; and

WHEREAS, the Board has reviewed the recommendation of the Sanitary Engineer and hereby approves the construction of the sanitary sewer beginning in Austintown in front of 32 North Turner Road, permanent parcel No. 48-0-056-027, then proceeding southerly along the west side of North Turner Road, approximately 182 L.F. to it's terminus in front of 7 North Turner Road, permanent parcel 48-0-056-094 as recorded by the Mahoning County Auditor; and

WHEREAS, any benefitting properties not participating in the cost of construction will reimburse to Mr. Frederick Romeo, owner, a pro-rata share based on cost per front foot, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditors Filing Fee has been submitted by Frederick Romeo and accompanies this resolution.

NOW, THEREFORE BE IT RESOLVED, by the Board of Mahoning County Commissioners, State of Ohio, that on the recommendation of the Mahoning County Sanitary Engineer, that Mr. Frederick Romeo is hereby authorized under Ohio Revised Code Section 307.73 to construct a sanitary sewer in Austintown Township, Mahoning County, Ohio.

BE IT FURTHER RESOLVED, that the non-participating benefitting properties as designated on plans in the office of the Mahoning County Sanitary Engineer shall reimburse Mr. Frederick Romeo a pro-rata share of the construction cost based on cost per front foot.

It was moved by Mr. Ludt, and seconded by Mr. Engler, that the foregoing Resolution be approved this 1st day of April, 1999.


