**AUTHORIZING THE WEST YOUNGSTOWN KINGDOM HALL OF JEHOVAH'S WITNESS,  
c/o JAMES ANDERSON, 163 OAKCREAST AVENUE, YOUNGSTOWN, OHIO 44515  
TO CONSTRUCT A SANITARY SEWER IN AUSTINTOWN TOWNSHIP  
OHIO IN ACCORDANCE WITH OHIO REVISED CODE SECTION 307.73.**

WHEREAS, the Board of Mahoning County Commissioners received a recommendation from the Mahoning County Sanitary Engineer to approve the construction of a sanitary sewer to be located in Four Mile Run Road and being approximately 393 L.F. in length; and

WHEREAS, the Board has reviewed the recommendation of the Sanitary Engineer and hereby approves the construction of the sanitary sewer beginning in Austintown in front of 503 North Turner Road, permanent parcel No. 48-0-066-120.01, then proceeding northerly along the east side of Four Mile Run Road 211 linear feet to a manhole then proceeding westerly 182 linear feet to its terminus in Lot No. 6 in the Osborn Plat No. 1 as recorded in Volume 37 at Page 9 in Mahoning County Record of Plats; and

WHEREAS, any benefitting properties not participating in the cost of construction will reimburse to The West Youngstown Kingdom Hall of Jehovah's Witness, owner, a pro-rata share based on cost per front foot; and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditors Filing Fee has been submitted by the West Youngstown Kingdom Hall of Jehovah's Witness and accompanies this resolution.

NOW, THEREFORE BE IT RESOLVED, by the Board of Mahoning County Commissioners, State of Ohio, that on the recommendation of the Mahoning County Sanitary Engineer, that The West Youngstown Kingdom Hall of Jehovah's Witness is hereby authorized under Ohio Revised Code Section 307.73 to construct a sanitary sewer in Austintown Township, Mahoning County, Ohio.

BE IT FURTHER RESOLVED, that the non-participating benefitting properties as designated on plans in the office of the Mahoning County Sanitary Engineer shall reimburse the West Youngstown Kingdom Hall of Jehovah's Witness a pro-rata share of the construction cost based on cost per front foot.


It was moved by Mrs. Sherlock, and seconded by Mr. Ludt, that the foregoing Resolution be approved this 10th day of June, 1999.


