

RESOLUTION

AUTHORIZING DARRYL E. PRUSKY,
18214 MAHONING AVENUE, MILTON, OHIO 44429,
TO PROCEED UNDER OHIO REVISED CODE SECTION 307.73
WITH THE CONSTRUCTION OF AN 8" WATER LINE
IN MAHONING AVENUE, MILTON TOWNSHIP

WHEREAS, a letter of application to proceed under the Ohio Revised Code Section 307.73 with the construction of a water line in Mahoning Avenue, Milton Township has been received by this Board, and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the water line and has recommended the Board approve the request to construct the water line, and

WHEREAS, any non-participants, specifically lot(s) on the north and south sides of Mahoning Avenue along the water line benefitting from the construction shall be required to pay a pro-rata share of the project costs calculated on the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been submitted by Darryl Prusky and accompanies this resolution.


NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Mahoning County, State of Ohio, that Darryl E. Prusky, 18214 Mahoning Avenue, Milton, Ohio 44429, be, and he is hereby authorized to proceed under Ohio Revised Code Section 307.73 with the construction of approximately 940 feet of 8" water line in Mahoning Avenue, beginning at the intersection of Forest and Mahoning Avenue(s) then traveling west and servicing the north and south sides of the roadway, Milton Township, in accordance with provisions regulating the construction of water lines in Mahoning County.

BE IT FURTHER RESOLVED, that any monies collected from non-participants shall be forwarded to Darryl E. Prusky.

It was moved by Mr. Lordi, and seconded by Mr. Carney, that the foregoing Resolution be approved this 29th day of April, 1993.


