

RESOLUTION

AUTHORIZING DOMINIC MARCHIONDA, DEVELOPER,
8303 MISTY RIDGE TRAIL, POLAND, OHIO 44514
TO CONSTRUCT A SANITARY SEWER IN POLAND TOWNSHIP
OHIO IN ACCORDANCE WITH OHIO REVISED CODE SECTION 307.73.

WHEREAS, the Board of Mahoning County Commissioners received a recommendation from the Mahoning County Sanitary Engineer to extend a gravity sanitary sewer approximately 1,750 feet in Dobbins Road, Poland Township; and

WHEREAS, the Board has reviewed the recommendation of the Sanitary Engineer and hereby approves the construction of the sanitary sewer beginning at an existing manhole at Dobbins Road and Tuscany Drive and extending easterly in Dobbins Road approximately 1,750 feet; and

WHEREAS, benefiting properties on the north and south side of Dobbins Road and listed on the attachment to this resolution are non participating for purpose of cost recovery; and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditors Filing Fee has been submitted by Dominic Marchionda Poland, Ohio and accompanies this resolution.

NOW, THEREFORE BE IT RESOLVED, by the Board of Mahoning County Commissioners, State of Ohio, that on the recommendation of the Mahoning County Sanitary Engineer, that Dominic Marchionda, Developer, 8303 Misty Ridge Trail, Poland, Ohio 44514 is hereby authorized under Ohio Revised Code Section 307.73 to construct a sanitary sewer in Poland Township, Mahoning County, Ohio.

BE IT FURTHER RESOLVED, that the non-participating benefiting properties as designated on plans in the office of the Mahoning County Sanitary Engineer and list attached to this resolution shall reimburse Dominic Marchionda a pro-rata share of the construction cost based on cost per front foot.

It was moved by Mrs. Sherlock, and seconded by Mr. Reese, that the foregoing Resolution be approved this 31st day of August, 2004.


