AUTHORIZING E.G.O. LAND COMPANY, 6600 SUMMIT DRIVE,
CANFIELD, OHIO 44406, TO PROCEED UNDER OHIO
REVISED CODE SECTION 307.73 WITH THE
CONSTRUCTION OF AN 8" SANITARY SEWER IN SUMMIT DRIVE,
SOUTH FROM SR 224, CANFIELD TOWNSHIP.

WHEREAS, a letter of application to proceed under Ohio Revised Code
Section 307.73 with construction of a sanitary sewer in Summit Drive, Canfield
Township has been received by this Board; and

WHEREAS, the Sanitary Engineer has reviewed the proposed route of the
sewer line and has recommended the Board approve the request to construct the
sanitary sewer line; and

WHEREAS, any non-participants along the line of the installation of
the sanitary sewer benefitting from the construction shall be required to pay a
pro-rata share of the project costs calculated on the front footage, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73
dated March 15, 1989, a one dollar (\$1.00) Auditor's Filing Fee has been
submitted by the E.G.O. Land Company and accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners
of Mahoning County, State of Ohio, that E.G.O. Land Company, 6600 Summit Drive,
Canfield Ohio 44406, be and they are hereby authorized to proceed under Ohio
Revised Code Section 307.73 with the construction of an 8" sanitary sewer
southerly in Summit Drive from SR 224, Canfield Township in accordance with
provisions regulating the construction of sanitary sewers in Mahoning County.


BE IT FURTHER RESOLVED, that any monies collected from non-


