

RESOLUTION

AUTHORIZING MARY HUTCHISON, 6904 RUBY COURT, AUSTINTOWN, OHIO 44515  
TO CONSTRUCT A SANITARY SEWER IN AUSTINTOWN TOWNSHIP, OHIO  
IN ACCORDANCE WITH OHIO REVISED CODE SECTION 307.73.

WHEREAS, the Board of Mahoning County Commissioners received a recommendation from the Mahoning County Sanitary Engineer to authorize Mary Hutchison to extend a gravity sanitary sewer approximately 1,776' feet; and

WHEREAS, the Board has reviewed the recommendation of the Sanitary Engineer and hereby approves the construction of the sanitary sewer beginning at an existing manhole located in Regal Drive, Austintown Township and extending approximately 576' south to the southerly right-of-way of Fairview Road, then continuing east in an easement along Fairview Road a distance of approximately 1,200', and

WHEREAS, there will be eight properties on the north side and eight properties on the south side of Fairview Road benefitting from the proposed sanitary sewer and are shown on the attached drawing, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditors Filing Fee has been submitted by Mary Hutchison and accompanies this resolution.


NOW, THEREFORE BE IT RESOLVED, by the Board of Mahoning County Commissioners, State of Ohio, that on the recommendation of the Mahoning County Sanitary Engineer, that Mary Hutchison, 6904 Ruby Court, Austintown, Ohio 44515 is hereby authorized under Ohio Revised Code Section 307.73 to construct a sanitary sewer in Austintown Township, Mahoning County, Ohio.

BE IT FURTHER RESOLVED, that the non-participating benefitting properties as designated on plans in the office of the Mahoning County Sanitary Engineer shall reimburse Mary Hutchison a pro-rata share of the construction cost based on cost per front foot.

It was moved by Mrs. Sherlock, and seconded by Mr. Ludt, that the foregoing Resolution be approved this 26th day of October, 2004.


