

RESOLUTION

AUTHORIZING KENNETH ZUZIK,
3911 FOX HAVEN DRIVE, CANFIELD, OHIO 44406
TO CONSTRUCT A SANITARY SEWER IN CANFIELD TOWNSHIP, OHIO
IN ACCORDANCE WITH OHIO REVISED CODE SECTION 307.73.

WHEREAS, the Board of Mahoning County Commissioners received a recommendation from the Mahoning County Sanitary Engineer to authorize Kenneth Zuzik to extend a gravity sanitary sewer approximately 448' feet; and

WHEREAS, the Board has reviewed the recommendation of the Sanitary Engineer and hereby approves the construction of the sanitary sewer beginning at an existing manhole located in Summit Drive approximately 800' south of Boardman-Canfield Road(US 224) in Canfield Township and then to extend approximately 448' south in the westerly right-of-way of Summit Drive, and

WHEREAS, there will be five (5) properties on the east side and four (4) properties on the west side of Summit Drive benefitting from the proposed sanitary sewer and are shown on the attached drawing, and

WHEREAS, in accordance with amended Ohio Revised Code Section 307.73 dated March 15, 1989, a one dollar (\$1.00) Auditors Filing Fee has been submitted by Kenneth Zuzik and accompanies this resolution.


NOW, THEREFORE BE IT RESOLVED, by the Board of Mahoning County Commissioners, State of Ohio, that on the recommendation of the Mahoning County Sanitary Engineer, that Kenneth Zuzik, 3911 Fox Haven Drive, Canfield, Ohio 44406 is hereby authorized under Ohio Revised Code Section 307.73 to construct a sanitary sewer in Canfield Township, Mahoning County, Ohio.

BE IT FURTHER RESOLVED, that the non-participating benefitting properties as designated on plans in the office of the Mahoning County Sanitary Engineer shall reimburse Kenneth Zuzik a pro-rata share of the construction cost based on cost per front foot.

It was moved by Mr. McNally, and seconded by Mr. Ludt, that the foregoing Resolution be approved this 29th day of December, 2005.


