Re: Installation of Sanitary Sewer
On Sheridan Road, Boardman Township
Between Holbrooke Road and Wingate Road.

Your applicants represent that they are property owners of substantially all of the lots facing Sheridan Road, Boardman Township, between Holbrooke Road and Wingate Road (Poland Crest Plat) and file this application to the honorable Board of County Commissioners pursuant to Ohio Revised Code 307.73 for the purpose of installing a sanitary sewer on Sheridan Road in said township between Holbrooke Road and Wingate Road for a distance of six hundred fifteen (615) feet according to plans and specifications now on file with the Mahoning County Engineers, Sanitary Sewer Department.

Your applicants further say that they are undertaking the installation of said sewer on their own behalf and have received bids from various contractors, the lowest being Mr. John Sikora, for the amount of forty-five hundred dollars (\$4500.00).

Your applicants further say that all of the property owners within the said area are participating in the project except William Davis and Patricia Davis, owners in common of Sub Lots #60 and #61, Poland Crest Plat, Boardman Township, Mahoning County, Ohio.

Wherefore, your applicants request the honorable Board of County Commissioners to establish rules and regulations for the protection of your applicants against tapping in to said sewer by any non-participating owner and to set up a reasonable tapping charge for any non-participant tapping in to said sewer and all other rights to which your participants may be entitled under the statute in such cases providing and to assure the return of said tapping charge by any non-participant to the applicants hereof.
