

RESOLUTION

AUTHORIZING THE A. BAGNOLI GRADING & EXCAVATING CO. TO INSTALL A SANITARY SEWER AND WATER LINE IN SIMON ROAD FROM LOT NO. 4 OF THE CLADIUS KOHANOV REPLAT NO. 1 TO LOT NO. 6 OF THE LOUIS RICCIUTI PLAT NO. 1 IN ACCORDANCE WITH THE PROVISION OF THE OHIO STATE REVISED CODE SECTION 307.73; BOARDMAN TOWNSHIP, MAHONING COUNTY, OHIO

WHEREAS, a letter of application requesting permission to install the above named utilities was filed with the Board of County Commissioners on January 5, 1971, and,

WHEREAS, a pro-rated share of the cost of construction shall be placed against non-participants owning land on either side of Simon Rd. along the route of the above described installation, and,

WHEREAS a list of non participants together with a certified copy of the completed costs shall be filed with the Mahoning County Sanitary Engineer at 863 Industrial Road so that a front footage charge can be computed in accordance with the provision of Section 307.73 of Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the Albert Bagnoli Grading & Excavating Company, 1809 Pointview Avenue, Youngstown, Ohio be authorized to install a sanitary sewer and water line in accordance with an approved set of Engineering drawings and in accordance with Section 307.73 R.C. of Ohio and,

BE IT FURTHER RESOLVED that in the event non-participating properties make application to connect to the utilities a pro-rated share of the costs based on the front footage shall be collected and returned to the applicant.

It was moved by Mr. PALERMO, seconded by Mr. BINDAS that the foregoing resolution be approved and passed this 6 day of JANUARY 1971.
