AUTHORIZING MAYO AND ORVETS, REALTORS,
OF 5020 MARKET STREET, BOARDMAN, OHIO,
PERMISSION UNDER SECTION 307.73 R. C.
OF OHIO TO PROCEED WITH THE INSTALLAT-
ION OF A SANITARY SEWER IN SOUTH AVENUE
FROM A POINT SOUTH OF THE INTERSECTION
OF U.S. 224, SAID POINT LOCATED ON THE
EASTERLY SIDE OF SOUTH AVENUE AND 1,025
FEET SOUTHERLY THEREFROM, THENCE NORTH-
ERLY AND FOLLOWING THE EASTERLY SIDE OF
SOUTH AVENUE TO U.S. 224, BOARDMAN TOWN-
SHIP, MAHONING COUNTY, OHIO.

WHEREAS, a letter of application to proceed under Section 307.73 R.C. with the installation of a sanitary sewer in South Avenue from a point south of the intersection of U.S. 224, said point located on the easterly side of South Avenue and 1,025 feet southerly therefrom, thence northerly and following the easterly side of South Avenue to U.S. 224 has been filed with the Board, and

WHEREAS, any non-participants along the line of the install-
ation shall be required to pay a pro-rated share of the cost of
construction, based on the front footage, and

WHEREAS, certified copies of the completed work shall be
filed at the office of the County Sanitary Engineer, 863 Indust-
rial Road, Youngstown, Ohio so that a tapping charge to non-
participants may be determined.

NOW, THEREFORE, BE IT RESOLVED by the Board of County
Commissioners of Mahoning County, State of Ohio that Mayo and
Orvets, Realtors, be and they are hereby authorized to proceed
with the installation of a sanitary sewer in South Avenue from
a point south of the intersection of U.S. 224, said point located
on the easterly side of South Avenue and 1,025 feet southerly
therefrom, thence northerly and following the easterly side of
South Avenue to U.S. 224 in compliance with the above named
section and according to the rules and regulations governing
sewer line construction in Mahoning County.

BE IT FURTHER RESOLVED that any monies collected from the
non-participants shall be forwarded to the applicant.
