RESOLUTION

AUTHORIZING H. WILLIAM TRIGG, JR. OF 1245  
BOARDMAN-POLAND ROAD, YOUNGSTOWN, OHIO, 44514,  
TO PROCEED UNDER SECTION 307.73 R. C. OF OHIO,  
WITH THE CONSTRUCTION OF AN 8-INCH SANITARY  
SEWER LINE APPROXIMATELY 700 FEET IN BOARDMAN-  
POLAND ROAD, BOARDMAN TOWNSHIP, MAHONING COUNTY,  
OHIO.

WHEREAS, a letter of application to proceed under Section  
307.73 R.C. of Ohio with the installation of a sanitary sewer  
line at the above described location has been filed with this  
Board, and

WHEREAS, any non-participants along the line of the install-  
ation shall be required to pay a pro-rata share of the construct-  
ion costs, based on the front footage, and

WHEREAS, certified copies of the completed work shall be  
filed at the office of the County Sanitary Engineer, 761 Indust-  
rial Road, Youngstown, Ohio, so that a tapping charge to non-  
participants may be determined, and

WHEREAS, in accordance with amended Section 307.73 R. C. of  
Ohio, effective August 23, 1972, a one dollar Auditors Filing  
Fee received of said organization or person accompanies this  
resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County  
Commissioners of Mahoning County, State of Ohio, that H. William  
Trigg, Jr. be, and he is hereby authorized to proceed under Sec-  
tion 307.73 R. C. of Ohio, with the construction of an 8-inch  
sanitary sewer line in Boardman-Poland Road from an existing  
sanitary manhole located approximately 260 feet east of South  
Avenue, thence easterly approximately 700 feet therefrom and  
serving the south side of Boardman-Poland Road only in Boardman  
Township, Mahoning County, Ohio, in accordance with the regulat-  
ions governing sewer line construction in Mahoning County.
