

RESOLUTION

AUTHORIZING RALPH G. INGLIS OF 946 BOARDMAN-POLAND ROAD, YOUNGSTOWN, OHIO, 44512, TO PROCEED, UNDER SECTION 307.73 R.C. OF OHIO, WITH THE CONSTRUCTION OF AN 8-INCH SANITARY SEWER IN BOARDMAN-POLAND ROAD, FROM AN EXISTING SANITARY MANHOLE, STATION 0+00, LOCATED APPROXIMATELY 950 FEET WEST OF SOUTH AVENUE, EASTERLY THEREIN APPROXIMATELY 600 FEET.

WHEREAS, a letter of application to proceed under Section 307.73 R. C. of Ohio with the construction of an 8-inch sanitary sewer line at the above described location has been filed with this Board, and

WHEREAS, any non-participants along the line of the installation shall be required to pay a pro-rata share of the construction costs, based on the front footage, and

WHEREAS, certified copies of the completed work shall be filed at the office of the County Sanitary Engineer, 761 Industrial Road, Youngstown, Ohio, so that a tapping charge to non-participants may be determined, and

WHEREAS, in accordance with amended Section 307.73 R. C. of Ohio, effective August 23, 1972, a one dollar Auditors Filing Fee received of said persons accompanies this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Mahoning County, State of Ohio, that Ralph G. Inglis be, and he is hereby authorized to proceed under Section 307.73 R.C. of Ohio, with the construction of an 8-inch sanitary sewer in Boardman-Poland Road, from an existing sanitary manhole, station 0+00, located approximately 950 feet west of South Avenue, easterly therein approximately 600 feet, in Boardman Township, Mahoning County, Ohio, in accordance with the regulations governing sewer line construction in Mahoning County.

BE IT FURTHER RESOLVED that any monies collected from non-participants shall be forwarded to the applicant.
